Comes now Probate Special Master, Emily H. Kawashima ("Master"), and hereby submits this Errata to the First Supplement to Probate Special Master's Report Re: Petition for Instructions #12, Filed August 9, 2024, filed October 24, 2024 ("Report").

Pages 2-3 – Paragraph (F) **Thomas Kaniho**:

The distribution for **Leebert Naboa** should be **ONE-ELEVENTH (1/11)** instead of one-sixth (1/6).

(F) **THOMAS KANIHO**

This decedent's settlement distribution was to be disbursed to the six heirs of the post-deceased surviving spouse under the laws of intestacy. The decedent had five children from another relationship who would not be entitled to any distribution under the laws of intestacy.

Your Master was informed that the descendants of the surviving spouse wants to divide the settlement 11 ways to include the four descendants of the decedent and one share to the heirs of predeceased child, Leonard Naboa. Your Master received the agreement that was partially signed by the beneficiaries. Should the agreement be fully executed, your Master would find and recommend this deceased class member's share of the *Kalima* settlement proceeds should be distributed as follows:
