**FIRST SUPPLEMENT TO PROBATE SPECIAL MASTER'S  
REPORT RE: PETITION FOR INSTRUCTIONS #25**

COMES NOW, EMILY H. KAWASHIMA, ESQ. ("Master"), duly appointed Probate  
Special Master to examine the Petition for Instructions #25, filed December 1, 2025 (the  
"Petition"), and respectfully submits this Report.

(K) **MARY PIMENTEL**

Your Master discussed this matter with your Special Probate Counsel and concludes that  
the Petition correctly stated the distribution. Your Master mistakenly focused on the language in

the Will, “deceased children who left surviving descendants,” but failed to attribute the children’s dates of death in relation to the decedent’s. As noted in the Petition, all of the children died after the decedent and therefore were “surviving” at her date of death. The post-deceased children’s estates would therefore control.

Your Master believes that it was the intent of the decedent that her children’s descendants receive her settlement, but the laws of intestacy must govern.

On the basis of the foregoing, your Master finds and recommends that this deceased class member’s share of the *Kalima* settlement proceeds should be distributed as follows:
