COMES NOW, EMILY H. KAWASHIMA, ESQ. ("Master"), duly appointed Probate  
Special Master to examine the Petition for Instructions #27, filed February 20, 2026 (the  
"Petition"), and respectfully submits this First Supplement to the Report.

(U) **MINNIE KAHIKILANI AKIONA**

Your Master spoke with the former attorney for the Estate of Albert L. Akiona regarding the conflicting language in the closing statement and the final receipt. He explained that the estate was very small but probate had to be opened in order to terminate the Conservatorship of the decedent. Because the amount was so small, Lucy Finnegan received the minimal proceeds. The attorney was unaware that the decedent had a predeceased child who was survived by descendants as that would not have been an issue for the Conservatorship proceeding.

Based on the information your Master provided to the estate attorney, he agreed that a distribution using the intestacy statutes would be appropriate.

On the basis of the foregoing, your Master does not alter her findings and recommendations that this deceased class member's share of the *Kalima* settlement proceeds should be distributed as follows:
