COMES NOW, EMILY H. KAWASHIMA, ESQ. ("Master"), duly appointed Probate Special Master to examine the Petition for Instructions #10, filed June 14, 2024 (the "Petition"), and respectfully submits this First Supplement to her Report.

W. JOSEPH DAMIEN DELAGINTE SR.

Your Master received correspondence from and spoke to Carol Ann Langley on or about September 3, 2024. She informed your Master that her sister, Nadine Chai, died on June 12,

2024. A copy of her death certificate is being filed under seal. Nadine was a widow and did not have any descendants. She also noted that the address of Quintin L. Delaginte, Jr. is now 730 Wilikina Drive, Apt. 304, Wahiawa, Hawaii 96786-1447.

Under Act 200, Section 560:2-103, if there is no surviving spouse, the estate passes to the issue of the decedent; “if they are all of the same degree of kinship to the decedent they take equally...” Your Master does not take any spousal or homestead elections into account due to the nature of the award and the date of death.

On the basis of the foregoing, your Master amends her findings and recommendations and now finds and recommends that this deceased class member’s share of the *Kalima* settlement proceeds should be distributed to:
