The Court requested that your Master provide an explanation as to why this decedent's last name differs from the name listed on her death certificate. Your Master corresponded with the decedent's daughter, Wendy Namoca, who relayed that the decedent's legal name at time of death was Gwendolyn Puaala Kim. When the decedent applied for Hawaiian Home Land, she was married to Wendy's father, Joseph Cugal. Joseph died in 1989 and the decedent remarried David Kim in 1992. David died in 2018. Attached under seal is Joseph Cugal's death certificate, the decedent's marriage certificate noting her marriage to David Kim in 1992 and David Kim's death certificate. Therefore, your Master would ask the record to reflect this decedent's name as GWENDOLYN PUAALA KIM. Your Master's original Findings and Recommendations do not change.
