**FIRST SUPPLEMENT TO PROBATE SPECIAL
MASTER'S REPORT RE: PETITION FOR INSTRUCTIONS #16**

COMES NOW, EMILY H. KAWASHIMA, ESQ. ("Master"), duly appointed Probate Special Master to examine the Petition for Instructions #16, filed December 3, 2024 (the "Petition"), and respectfully submits this First Supplement to Probate Special Master's Report #16, filed on December 23, 2024.

(D) **ELINOR LEHUA BRANCO**

Your Master received an email from Timothy Smith Lewis, who is listed as the surviving spouse of the decedent's predeceased daughter, Dorothy Mae Lehua Smith-Lewis.

He informed your Master that he is not related to this family and does not know any of them. Your Master then spoke to the decedent's daughter, Diana Berrien, who informed that Dorothy was divorced at her time of death (although the death certificate indicates otherwise). Ms. Berrien confirmed that Ohelo Smith and Kamalei Smith are Dorothy's only descendants.

Based on this additional information, your Masters findings and recommendations remain the same.

(G) CATHERINE LEINAALA GAGNON

Your Master received and reviewed supplemental documents that were provided to the claims administrator. The distribution recommendation does not change, however one of the beneficiaries' name should be corrected from **EDWINA LAGAMEN** to **EDWINA LANGAMAN**.

(K) HELENA KALAMA SILVA (also known as HELEN KALAMA SILVA)

Your Master received information from the decedent's family that the names of beneficiaries "SAN I. SILVA" should be corrected to "**XAN I. SILVA**" and "NORNETTE P. CALLARDO" should be corrected to "**NORNETTE P. GALLARDO.**" Based on this additional information, your Masters findings and recommendations remain the same.

(R) ELLEN ALBERTINA CLEVELAND LIU BAUTISTA

Your Master received a response from beneficiary, Patricia Martin, who confirmed that her parents did not have a will or trust and that she, Bernard Cleveland and Melvyn Liu, Jr., are the decedent's only descendants. Based on this additional information, your Masters findings and recommendations remain the same.

(BB) JOSEPH KALEIALOHA MALIA

Your Master received a response from beneficiary, Trinidad Malia, who confirmed that

the decedent did not have a will or trust and that all of the decedent's descendants are also her children. Based on this additional information, your Masters findings and recommendations remain the same.

(CC) SILVA KAIPO KAUPU SR.

Your Master received a response from beneficiary, Sylvia Tayamen, who confirmed that her parents did not have will or trust and that she, Bernard Kaupu and Silva Kaupu, Jr. are the decedents only descendants. Based on this additional information, your Masters findings and recommendations remain the same.
