
**ORDER ALLOWING FOR SERVICE BY PUBLICATION

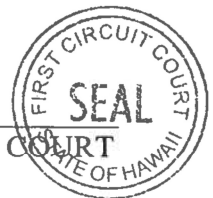
ACCORDINGLY, IT IS HEREBY ORDERED:
