**WHY:** The Kalima Lawsuit was filed in **December 1999** by approximately **2,700** Hawaiian Home Land Waitlist Beneficiaries citing over **4,000** Claims of Breach of Trust by DHHL between **1959** (Statehood) and **1988**. It has spanned the Administrations of Governor Cayetano, Governor Lingle, Governor Abercrombie and Governor Ige, along with their respective appointees at the State Agency of DHHL. A 23-year period.

In 2022, the Hawaii State Legislature appropriated **\$328,000,000** to finally, Settle the Case with the Kalima Lawyers and their Clients.
