COMES NOW, EMILY H. KAWASHIMA, ESQ. ("Master"), duly appointed Probate
Special Master to examine the Petition for Instructions #29, filed May 22, 2026 (the "Petition"),
and respectfully submits this Second Supplement to the Report.

(X) ELVIN K. HAO

Your Master received additional information that the surviving spouse of the decedent, Frances Hao, died on or about April 25, 2026. Her death certificate shall be filed under seal. Frances had a total of seven children, three of whom were also the descendants of the Deceased Class Member. The other four children were from a prior relationship.

Pursuant to HRS §560:2-102, since one or more of the decedent's surviving descendants are not descendants of the surviving spouse, the surviving spouse is entitled to receive the first of a certain dollar amount. Your Master has confirmed that the settlement award does not exceed that amount. In addition, the surviving spouse submitted a letter to the Claims Administrator, disclaiming her settlement and requesting that the proceeds be distributed equally to the three children who are descendants of the Deceased Class Member and his surviving spouse. See Exhibit “2.”

On the basis of the foregoing, your Master amends her findings and recommendations and finds and recommends that this deceased class member’s share of the Kalima settlement proceeds should be distributed as follows:

JENNIFER KAAWALOA – ONE-THIRD (1/3)
NAOMI HAO – ONE-THIRD (1/3)
ELIZABETH KAHEA MAGGIO – ONE-THIRD (1/3)
