COMES NOW, EMILY H. KAWASHIMA, ESQ. ("Master"), duly appointed Probate
Special Master to examine the Petition for Instructions #27, filed February 20, 2026 (the
"Petition"), and respectfully submits this Second Supplement to the Report.

(B) AUSTIN KAULUHAIMALAMA WHITING

Your Master recently learned that the Austin Kauluhaimalama Whiting, Jr. Revocable Trust, dated September 17, 1991, as amended, has been fully distributed and terminated. It is your Master's understanding that all accounts have been closed and therefore a settlement payment to the Trust would require opening a new account. The attached deed indicates that the beneficiaries are the same as if this estate was distributed in intestacy. See Exhibit "2."

Based on the above information, and in the interest of efficiency, your Master finds that a distribution using the intestacy statutes would be appropriate.

On the basis of the foregoing, your Master amends her findings and recommendations and now finds and recommends that this deceased class member's share of the *Kalima* settlement proceeds should be distributed as follows:

DWIGHT IMAIKALANI WHITING – ONE-THIRD (1/3)
PALANI KEALOHA WHITING – ONE-THIRD (1/3)
JAY POMAIIKA'I THOMAS – ONE-THIRD (1/3)
