**THIRD SUPPLEMENT TO PROBATE SPECIAL MASTER'S REPORT

COMES NOW, EMILY H. KAWASHIMA, ESQ. ("Master"), duly appointed Probate Special Master to examine the Petition for Instructions #2, filed January 19, 2024 (the "Petition"), and respectfully submits this Third Supplement to Master's Report, filed March 14, 2024.

At the hearing held on April 5, 2024, your Honor requested supplemental findings and recommendations as follows:

M. JOSEPH AKEAU AKAU

Your Master reviewed the facts contained in Petition #2 as well as the data provided in the Facilitator database. The decedent's death certificate lists marital status as Married to Ramona Esther Cummings, now known as **RAMONA AKAU**.

After the filing of Petition #2, additional documents were submitted to the claims administrator. Ramona Akau died on or about December 27, 2023. A true and correct copy of her death certificate is being filed under seal. She and Joseph Akau had three children, one of whom is now deceased. Danette Kaahanui is the deceased child and left three descendants as noted below. A copy of her death certificate is being filed under seal.

Jill Rodrigues appeared at the hearing on this Petition #2 on April 5, 2024, and stated on the record that her mother did not have a Will. Therefore her share passes through intestacy. Pursuant to HRS §560:2-103, the decedent's descendants by representation shall receive the distribution.

On the basis of the foregoing, your Master amends her prior findings and recommendations and now finds and recommends that this deceased class member's share of the *Kalima* settlement proceeds be disbursed to the descendants of the decedent's surviving spouse, **RAMONA AKAU**, as follows:
